HOW A PHARMACEUTICAL MANUFACTURER MODERNIZED SERIALIZED OPERATIONS AND STREAMLINED REGULATORY COMPLIANCE

A U.S.-based pharmaceutical company with operations in New York and Ohio, develops, manufactures, and sells generic and branded specialty injectables, including human and animal health products. Facing the need to reduce operational complexity and ensure DSCSA compliance, the company turned to Antares Vision Group to harmonize its serialization and warehouse workflows across its facilities.

Their existing legacy serialization system had limited functionality and did not provide the necessary functionality for enhanced operations in the warehouse. While the company's ERP and line-level serialization systems were not up for replacement, the fragmented environment made it difficult to maintain compliance and efficiency.

Antares Vision Group was selected to deploy a modular, integrated solution that could centralize warehouse and serialization processes, enable compliance, and support advanced scenarios, such as sampling, all while maintaining compatibility with existing legacy infrastructure and delivering rapid results.

- Need for custom sampling capability, enabling unpacking of serialized items from a case and relabeling
- Aggressive timeline with multi-vendor coordination

- Administration: Manage business rules, reason codes, material UOM, and clearing orders
